Discussion

Digital ethics is an individual's ability to realize, exemplify, adapt, rationalize, consider, and develop digital ethical governance (*netiquette*) in everyday life. Digital ethics reflects a person's behavior and manners in utilizing digital media for various purposes and interests. In the era of society 5.0, a person is demanded not only to be proficient in using technology, but also to be able to carry out the mediation process productively. With digital ethics, activities and interactions in the digital world become more comfortable. (Kusumastuti et al., n.d., p. 9)

Based on data from the Internet Survey Report, it shows that internet users are dominated by teenagers. Teenagers have unstable emotions, are easily influenced, are in the process of finding identity, are proud and feel great when they are known by many people. The process of showing oneself can be done in various ways, including through achievements, through one's talents and even by doing bad actions. This bad action is carried out through various digital media accounts that are often accessed by children. Some of these actions include the spread of hoaxes, cyberbullying, body shaming, violations of Intellectual Property Rights (IPR), to internet access that smells of pornography.(Terttiaavini & Saputra, 2022, p. 2157)

A child is expected to have ethical indicators in accessing the digital world, including:

- 1. Children have knowledge about which information contains hoaxes, hate speech, pornography, bullying and negative content that disturbs the morale and mentality of children.
- 2. Children must have basic knowledge of interacting, participating, and collaborating in digital space in accordance with digital ethical principles and applicable regulations, this is an important achievement for every child in social media, so that they are not contaminated with associations that are not in accordance with applicable norms. and then to get away from.
- 3. Basic knowledge of interacting and transacting electronically in the digital space in accordance with applicable regulations, this can be an important behavior for children to do. Karen nowadays many children top up online payments for every game they play, sometimes children exceed the limit in transactions .(Kusumastuti et al., n.d., p. 10)

Application of Digital Ethics to Children's Morals

Based on the results of theoretical studies regarding the importance of digital ethics and children's morals as indicated by the increasingly global advancement of information and

communication technology, researchers can formulate things that can be used as alternative choices in the era of society 5.0 as follows:

- 1. The teacher's teaching pattern is closely related to digital ethics and morals in children. Teachers should provide appropriate teaching patterns for children's moral development. Based on observations of the results of moral development, children understand wise behavior and distinguish between good and bad behavior in social media. Things that teachers need to do are: introduce moral values that apply in society, and involve children in seeing problems in social media, instill a sense of responsibility for what digital platforms are consumed, teach discipline, strengthen conscience to always be wise in choosing digital shows that are suitable for viewing. beneficial. In addition, teachers also need to strengthen altruistic behavior and make themselves models/role models in terms of carrying out digital and moral ethics in this millennial era.
- 2. Parents' lack of concern for education and their social environment has resulted in children accessing various digital platforms freely and uncontrollably.
- 3. The community environment is a community for individual residence. The environment causes the creation of patterns of interaction between individuals. Association in this environment can influence and change the behavior, character, customs, mind, knowledge and ethical behavior of individuals. This can be interpreted as the environment and association in schools in particular can result in progress or damage/setbacks. This is where the teacher's role as a facilitator and also filteration is needed in the onslaught of increasingly easy access to any digital platform.
- 4. Peers (peers) tend to be of the same age level. From this peer group, children get feedback. Children in peer friendship also have interests, good behavior and fight each other's courage to cause trouble. Many things influence peer behavior such as: they imitate each other, give psychic influence, to great sympathy. This peer friendship group has positive groups and negative/bad groups. (Madyawati & Rafiq, n.d., p. 138)

In addition, there are several factors that can increase children's morality in utilizing digital media in the era of society 5.0, namely:

- 1. The teacher as an opinion leader is considered a figure who is always highlighted by the community, both for his performance, personality, or character who can be an example for his students. Teachers are entrusted with teaching, guiding, and educating students to become qualified and tough individuals. A quality person can be seen from his morals, both from the way he speaks (orally) and the way he behaves (non-verbally). (Herawati et al., 2022, p. 18).
- 2. Parents who have the responsibility of intellectual education for their children. Providing education, useful habits of thought, cultural awareness, and scientific civilization in the development of technology.
- 3. Habits/habits that are built in everyday life. Habits that are carried out daily have a major influence in the lives of children. There are a number of things that are important to note, including a) every child must be wise in accessing the virtual world and choosing which one is beneficial for him/her; b) The duration of time playing in the digital world must be limited so as not to interfere with children's activities; c) Everything that is accessed by

children can affect the good or bad of the child's morals, so the ability to sort and filter all of this content is very necessary. (Madyawati & Rafiq, n.d., p. 139)

Conclusion

Processing of digital information that can be obtained anywhere and anytime allows everyone to obtain a wide variety of content that can be obtained, for example, in accessing Google, YouTube, Facebook, and all kinds of other social media that can be accessed as long as they can be connected to the internet network.
