IMPLEMENTATION AND RESULTS OF THE ISLAMIC RELIGIOUS EDUCATION TEACHER PROGRAM IN OVERCOMING AKHLAKULMAZMUMAH OF ELEMENTARY SCHOOL STUDENTS

ABSTRAK

Tujuan penelitian ini untuk mengetahui pelaksanaan dan hasil program guru Pendidikan Agama Islam dalam mengatasi akhlakul mazmumah di SDN Sawah 04 Ciputat Tangerang Selatan. ABSTRACT

The purpose of this study was to determine the implementation and results of the Islamic Religious Education teacher program in overcoming akhlakul mazmumah at SDN Sawah 04 Ciputat South

Tangerang. The approach used in this research is qualitative research. The data collection methods used are observation, interview and documentation methods. Observation and interview methods are used to find data about the implementation and results of the Islamic Religious Education teacher program in overcoming students' akhlakulmazmumah at SDN Sawah 04 Ciputat South Tangerang. The documentation method sought data on the geographical location of the school, data on the condition of teachers, the condition of students, and facilities and markets. As for checking the validity of the data, this research uses credibility by extending observation, increasing persistence in research and triangulation. The results showed that the implementation and results of the Islamic Religious Education teacher program in overcoming students' akhlakul mazmumah were carried outby means of implementation in providing exemplary to students, habituation carried out by students, advice and punishment given to students by PAI teachers. And the results of the implementation of the program show a decrease in akhlakul mazmumah such as skipping school, badmouthing their own friends, lying, making fun, disturbing their friends in class, betraving and not wanting to obey teachers and parents. The contribution of the research results makes an output that can provide many lessons for PAI teachers in overcoming problems related to the formation of mazmumah morals.

INTRODUCTION

Morals are basically one of the characteristics inherent in a person, which merges with behavior or action. When the inherent behavior is bad and harmful, this is called akhlakul mazmumah. Conversely, if the behavior shown is positive and commendable, it is called akhlak mahmudah (Syarifah Habibah 2015).

In this case, it is more focused on akhlakul mazmumah, this character is all human behavior that can lead him to destruction and destruction (Mustofa 1997). The destruction and devastation accused by the existence of akhlakul mazmumah does not only depend on the attitude away from religion, but is also influenced by several factors. One of them is that moral values that are not based on religion tend to change with the circumstances of place and time. Therefore, the occurrence of akhlakul mazmumahresults from a combination of factors that make students lose good morals (Zakiah Daradjat 1989).

Many factors cause akhlakul mazmumah to occur in students, so that

individuals do things that are not in accordance with school rules, as well as religious rules. Some students who are involved in actions that violate school rules can be said to have bad traits, such as lying, arrogance, envy, spite, skipping, opposition, betrayal, anger, cowardice, wanting to be praised and so on (Hasan Basri, 2000).

Based on the results of interviews conducted by researchers with Mrs. Satyah at SDN Sawah 04 Ciputat South Tangerang, it showsthat there are various forms of akhlakul mazmumah that arise from students during learning hours and during recess. The forms of akhlakul mazmumah of students that occur include being hasty in everything theydo, being greedy, envying their friends when their friends get praise from the teacher, being defiant, angryand wanting to be praised (Satyah 2023).

The morals that should be possessed by elementary schoolstudents include good manners, honesty, and doing good to others. Not only at school students can familiarize good morals at home and parents need to supervise them. However, a teacher also has this task (Muhtadi, 2011). The behaviors carried out byindividuals are related — to socialinteractions or behaviors that have animpact on themselves. Although theindividual concerned may not feeldisturbed or see a problem with his behavior, people around him will feela disturbing impact due to the actionsof these students (Abu Darwis, 2006).

The actions of these students are of great concern to schools and society, because of their role as the next generation of the nation. If many students behave despicably, it will be a serious problem for the fate of the nation in the future. If the behavior, morals and morals of the younger generation experience a decline, this nation will also experience a decline (Ani Yuniati et al., 2017).

The number of despicable behaviors committed by students will experience the decline of this nation, as stated in the words of Allah SWT in QS. Al-Maidah verse 90:

Meaning: "O you who believe, indeed (drinking) wine, gambling,

(sacrificing to) idols, casting lots with arrows, are among the deeds of the devil. So avoid those deeds s that you may have good fortune" (Ministry of Religious Affairs, Al-Qur'an and Translations, 1996)

From the verse above, it can be seen that doing something that is prohibited by religion is a big sin. Akhlakul mazmumah is usually done by students who lack supervision and attention from teachers and parents (Shofwatul Qolbiyyah, 2016). Therefore, supervision from various parties is very necessary, both from the family, community, school and those who play an important role in fostering or directing students incontrolling emotions at school (Mumtahanah, 2018).

As an educator at school must carry out a program, especially Islamic religious education teachers not only increase student knowledge, but in terms of fostering noble morals or character and positive thinking patterns for students, both at schooland in the community. Related to the Islamic religious education teacherprogram in overcoming students' akhlakul mazmumah in accordancewith what is explained in Al-Qur'an Surah An-Nahl verse 125:

Meaning: "Call (people) to the way of your Lord with wisdom and good teaching and debate them in a better way. Indeed your Lord is the One who knows best who strays from His path and He knows best who is guided" (Ministry of Religious Affairs, Al-Qur'an and Translations, 1996).

The meaning of the verse above is closely related to the Islamic religious education teacher program in overcoming students' *akhlakul mazmumah*. Teachers as educators provide lessons to students with various wisdom and noble character. The Islamic religious educationteacher program is an effort to improve a process so that studentsachieve the success of the process andthe results achieved (Syaiful Bahri Djamarah and Aswan Zain, 2006).

The success of the process and the results achieved in overcomingstudents' *akhlakul mazmumah* is that they can grow well and avoid *akhlakul mazmumah*. And a teacher must be able to be a friend and parentso that students feel comfortable and can tell about what they are experiencing (Widiasworo, 2017).

Based on the background described above, the researcher is interested in conducting research on the implementation and results of the Islamic religious education teacher program in overcoming *akhlakul mazmumah of* elementary school students.

DISCUSSION

Implementation and Results of the Islamic Religious Education Teacher Program in OvercomingStudents' Akhlakul Mazmumah

Every elementary school has several problems that exist, such as *akhlakul mazmumah*, namely beinglate for school, disturbing friends in class and so on. Therefore, teachers must have a program to overcome *akhlakul mazmumah*.

Based on the findings of theresearcher's interview conducted withMrs. Satyah as the Islamic Religious Education teacher at SDN Sawah 04 Ciputat South Tangerang, namely:

How do you identify the program objectives in overcoming students' *akhlakul mazmumah*? Answer: "As an Islamic religious education teacher, in identifying program objectives in overcoming students' akhlakul *mazmumah*, it can be seen through their daily lives at school, as well as during class hours, so that I know students who have *akhlakul mazmumah* such as beinglate for school, disturbing their friends in class or speaking harshly with teachers or friends".

According to you, how is your program in overcoming students' *akhlakul mazmumah* at school? Answer: "The program that I do to overcome students' akhlakul *mazmumah* at school is by exemplary, habituation, advice, and punishment. With this, students will understandand avoid these *moralsul mazmumah*".

How do you overcome students'akhlakul mazmumah at school? Answer: "Just like the strategies I do,but in this effort involves otherteachers, especially the class teacher. Because with this involvement it will be easy to overcome akhlakul mazmumah at school".

What is your solution regardingstudents' *akhlakul mazmumah*? Answer: "For solutions regarding akhlakul *mazmumah* at school, it must involve parents to overcome *akhlakul mazmumah*, because it is not fully supervised at school. In

addition, with strategies such as giving advice and punishment, it is already a solution toovercome students' akhlakul*mazmumah* at school".

According to you, what are yourobstacles in overcoming students'akhlakul mazmumah at school? Answer: "The obstacle is that each student has a different character and attitude and sometimes parents also allow it, parents should not support their children to have akhlakul mazmumah, such as skipping school and disturbing their friends in class" (Satya, PAI teacher, 2023).

Based on the explanation above, the researcher concludes that the Islamic religious education teacher's program in overcoming students' akhlakul mazmumah is verynecessary, because without a program carried out by the teacher, the akhlakul mazmumah that students have is increasing, therefore the needfor a program needed by the teacher.
