IMPLEMENTATION OF FIELD LEARNING PROGRAM FOR STUDENTS

DISCUSSION

Implementation of Field Learning Program for Students

The basic principle of good learning is the ability of a person who has alignment with his field, completing his work with a full sense of responsibility to be given an authority, as well as to his teacher who has the main task in carrying out learning, the responsibility of teaching in the classroom and the person concerned must be given authority, no need for intervention from supervisors or school heads for the purpose of creating successful learning. Character development in students

To create and realize success in the process of field learning programs at school in developing student character, requires strategic steps and effective efforts made by teachers in shaping student character. Factors driving the learning program in character development in students

The cultivation of character education is related to Islamic religious education. Both are interrelated to form a positive person. Because religious education itself becomes the realization of thoughts of faith and sharia towards the creator (Elihami, 2018)

PPL (Field Learning Practice) in its activities, students and students are asked by the community to become temporary teachers at the Al-Qur'an Education Park. Practicing knowledge in reading the Qur'an as taught at school. Participating in religious activities that have become a routine every week. Not only that, students and students who are mainly male are also asked to be muadzin. This program runs for 10 days. It can be an example for the surrounding children and keep the negative views of the surrounding community.

Inseparable from that, there are factors that hinder the lack of awareness, the seriousness of learning students and the frequent playing of social media so that they are less broad in understanding the subject (Zakarya, 2023).

The children's ability in the field of religious literacy is lacking, facilities and infrastructure as well as the lack of mastery of students in applying teaching methods at TPQ make obstacles in conditioning the classroom atmosphere. Due to the lack of seriousness of students before the PPL was implemented, making the knowledge taught to children less mature. Then the environmental conditions are less supportive. The reason is that PPL activities are carried out in areas with difficult internet access and public places. From some of these obstacles, it makes an evaluation in the future so that from the school institution to prepare more carefully for students who will run later (Sofyan, 2018).

The government has also supported practical programs in schools. As is the case in the 2013 curriculum which focuses on student character. Not only in terms of material, but learning instruments that can shape student character. The implementation of character education is based on Pancasila education which is the main source of education in Indonesia. Therefore, learning practices in each school are different (Ningsih, 2015).

CONCLUSION

Based on the research above, it can be concluded that related methods in instilling moral character by means of lecture methods, habituation and exemplary, and also encouragement from several factors can be able to open the hearts of students who do PPL to become moral personalities.
